AN ORDINANCE

RECLASSIFYING PARCELS OF LAND OWNED BY MLO SUMMIT CORP. WITH TRANSFER CERTIFICATE OF TITLE NO. T-258104(M) WITH TOTAL AREA OF EIGHT THOUSAND THREE HUNDRED NINETY SIX SQUARE METER (8,396 SQM) LOCATED AT BARANGAY STA ROSA 1, MARILAO, BULACAN FROM AGRICULTURAL TO MIX INDUSTRIAL AND COMMERCIAL ZONE

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

Section 2. RECLASSIFICATION. The parcels of land by MLO Summit Corp. With Transfer Certificate of Title No. T-258104(M) with total area of Eight Thousand Three Hundred Ninety Six Square Meter (8,396 Sqm) located at Barangay Sta Rosa 1, Marilao, Bulacan from Agricultural to Mix Industrial and Commercial Zone

Section 3. MANNER OF UTILIZATION. The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Marilao Bulacan and other applicable laws, rules and regulations.

Section 5. EFFECTIVITY. This ordinance shall take effect upon approval.


