MUNICIPAL ORDINANCE NO - 832

Introduced by Councilor Mark Joseph L. Guillermo and seconded by all members of the Sangguniang Bayan Present.

AN ORDINANCE

RECLASSIFYING PARCELS OF LAND OWNED BY MR. JOSEPH TIU WITH TRANSFER CERTIFICATE OF TITLE NO. 040-2017010793 WITH TOTAL AREA OF FORTY TWO THOUSAND EIGHT HUNDRED FOUR SQUARE METER (42,804 SQM) LOCATED AT BARANGAY LAMBAKIN, MARILAO, BULACAN FROM AGRICULTURAL TO INDUSTRIAL.

Section 1. AUTHORITY TO RECLASSIFY. Section 20 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers the Sangguniang Bayan to enact an ordinance reclassifying an agricultural land to non-agricultural and to provide for the manner of their utilization.

Section 2. RECLASSIFICATION. The parcels of land by Mr. Joseph Tiu with Transfer Certificate of Title No. 040-2017010793 with total area of Forty Two Thousand Eight Hundred our Square Meter (42,804 Sqm) located at Barangay Lambakin, Marilao, Bulacan From Agricultural To Industrial.

Section 3. MANNER OF UTILIZATION. The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Marilao Bulacan and other applicable laws, rules and regulations.
