PROVIDING FOR SUPPLEMENTAL BUDGET BOTH NO. 2 FOR GENERAL FUND WITH TOTAL AMOUNT OF NINE MILLION PESOS (P9,000,000.00), AND ECONOMIC ENTERPRISE AMOUNTING TO SIX HUNDRED SEVENTY FIVE THOUSAND SIX HUNDRED ONE PESOS FIFTY FIVE CENTAVOS (P675,601.55) FOR CALENDAR YEAR 2017 COVERING VARIOUS EXPENDITURES FOR THE OPERATION OF THE MUNICIPALITY OF MARILAO, AND FURTHER AUTHORIZING THE MUNICIPAL MAYOR TO SIGN AND EXECUTE FOR IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO, CONTRACT AGREEMENTS WITH THE WINNING BIDDERS OF PROJECTS COVERED HEREIN, SUBJECT TO EXISTING AUDITING LAWS AND ISSUANCES.

Be it ordained by the Sangguniang Bayan, that:

Section 1. The amount of Nine Million Six Hundred Seventy Five Thousand Six Hundred One Pesos and Fifty Five Centavos (PHP 9,675,601.55), or so much thereof as may be necessary, is hereby appropriated out of the unappropriated, available and/or existing funds in the Municipal Treasury, for Supplemental Budget Both No. 2 for General and Economic Enterprise covering various expenditures for the operation of the Municipality of Marilao, Province of Bulacan, to wit:





Section 3. The Municipal Mayor is hereby authorized for and in behalf of the Municipal Government of Marilao, Bulacan, to execute and sign Contract Agreements with the winning bidders of the projects covered herein, subject to existing auditing laws and issuances.


