ADOPTING AND APPROVING THE AMENDMENT OF SUB-ITEM 2, ITEM D (ROADS AND BRIDGES) UNDER PART “I. PREVENTION AND MITIGATION” OF THE 2018 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) OF THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.

WHEREAS, on November 27, 2017 this Sangguniang Bayan had passed a Resolution adopting and approving the Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) for 2018 of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) in the Municipality of Marilao, Province of Bulacan;

WHEREAS, on April 3, 2018, the Office of the Secretary to the Sangguniang Bayan received an endorsement letter from the Office of the Mayor, requesting the Honorable Sangguniang Bayan to pass a Resolution adopting and approving the amendment of Sub-Item 2, Item D (Roads and Bridges) under Part “I. Prevention and Mitigation” of the 2018 Local Disaster Risk Reduction and Management Fund Investment Plan (LDRRMFIP) of the Municipality of Marilao, Province of Bulacan;

WHEREAS, said endorsement letter contains a copy of Resolution No. 01, Series of 2018 dated March 27, 2018 of the Municipal Disaster Risk Reduction and Management Council (MDRRMC) of the Municipality of Marilao, Province of Bulacan;

WHEREAS, MDRRMC Resolution No. 01, Series of 2018 recommended a piecemeal amendment due to typographical error attributed to similar sounding names involving Sitio Patulo, Loma de Gato and **Sitio Hulo**, Loma de Gato, all in this Municipality;

WHEREAS, the same is in conformity with standard government comity in delivering basic services to the general public;


