#### RESOLUTION

**AUTHORIZING THE MUNICIPAL MAYOR HON. JUANITO H. SANTIAGO FOR AND IN BEHALF OF THE MUNICIPAL GOVERNMENT OF MARILAO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE III, CITY OF SAN FERNANDO, PAMPANGA, REPRESENTED BY ITS REGIONAL DIRECTOR GEMMA B. GABUYA FOR THE IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS IN THE MUNICIPALITY OF MARILAO, PROVINCE OF BULACAN.**

**WHEREAS**, On April 5, 2018, the Office of the Secretary to the Sangguniang Bayan received an endorsement letter from the Office of the Mayor, requesting a Sangguniang Bayan resolution to authorize the Hon. 
