RESOLUTION

APPROVING THE REALIGNMENT OF THE AMOUNT OF THIRTY MILLION FIVE HUNDRED THOUSAND PESOS (P30,500,000.00) FROM UNUSED PORTION OF THE TWENTY PERCENT (20%) DEVELOPMENT FUND OF THE 2018 ANNUAL INVESTMENT PROGRAM TO FUND CERTAIN PROJECTS OF THE MUNICIPALITY OF MARILAO, BULACAN.

WHEREAS, the Municipal Development Council of Marilao, in its Municipal Development Council Resolution No. 2018-02 dated April 5, 2018, adopted and approved to realign the amount of Thirty Million Five Hundred Thousand Pesos (P30,500,000.00) from the unused portion of the Twenty Percent (20%) Development Fund of the 2018 Annual Investment Program to fund certain projects of the Municipality of Marilao, Bulacan, stated in detail in Annex "A" attached therewith;

WHEREAS, the same resolution was forwarded to this Sangguniang Bayan for its appropriate action;
